TO: THE MEMBERS OF THE GREATER LOON LAKE ASSOCIATION.

Dear Sir or Madam:

This letter will, I hope, bring you up to date on what is being done about the rebuilding of the dam at the foot of Loon Lake. As you probably already know, all the stop logs were removed from the existing dam last September, because the Department of Lands and Forests were fearful that the spring run off would completely destroy the dam. The Department, at that time, applied for an appropriation to build a new dam and I am pleased to say that I have recently been informed by Mr. Walter Rice, the Engineer in charge for the Department of Public Works, that this appropriation has been approved and that the project will be undertaken, as soon as the weather permits.

They propose to build a road one mile in length, running north from the existing Hydro Electric Power Commission road parallelling their transmission towers. When this road is completed, the existing dam will be used as a coffer dam, while the new abuttments are constructed in the narrow rock gorge, immediately below the present dam site. The future water level is to be maintained at the crest level of the present dam.

Since a road is to be built to the new dam, the District Forester will be in a much better position to make sure that the water levels are maintained, by constant supervision. The water level of the lake will probably remain near its present low level for the major part of this summer season. This Association proposes to rebuild the dock at the landing, on a much more permanent basis this spring, this work being facilitated by the low water. Since this work will cost the Association a considerable sum of money, in the neighborhood of \$75.00, we are most anxious that all those cottagers who did not join the Association this year, should forward their \$5.00 yearly dues.

Mr. Ed. Morley, Reeve of the Township, has promised again that this spring more gravel will be placed on the new road running from the landing to Oborne Point.

Should you have any questions regarding the above matters, I will be most happy to attempt to answer them.
