CONVEYANCE OF CERTAIN PUBLIC ROAD ALLOWANCES UNDER THE JURISDICTION OF THE CORPORATION OF THE TOWNSHIPS OF KALADAR, ANGLESEA & EFFINGHAM

## PROCEDURES FOR APPLYING FOR CONVEYANCE

- Discuss the matter with the adjoining owners on all sides of the property and obtain verbal agreement as to the location of the extended property lines on the public lakeshore road allowance.
- Obtain all forms application, consent, sketch from the Kaladar, Anglesea & Effingham Township Municipal Office, Flinton, Ont., KOH 1PO. Phone 613-336-2286.
- 3. Return the application, the other required forms and the fee of \$250.00, payable to the Townships of Kaladar, Anglesea & Effingham, to the Kaladar, Anglesea & Effingham Township Municipal Office. No applications will be considered by Council until all required forms are received and the fee is paid in full.
- 4. The Municipal Council of the Corporation of the Townships of Kaladar, Anglesea & Effingham, in accordance with the Municipal Act, R.S.O. and conveying of any public road allowances under its jurisdiction. Before a by-law is passed for applications approved by Council, the following procedures must be followed
  - a) A notice of the proposed by-law must be published once a week for four consecutive weeks.
  - b) A notice of the proposed by-law must be posted for at least one month in six public places in the neighbourhood of the land to be conveyed.
  - c) Council must hear any person that claims his land will be prejudicially affected by the by-law and who applies to be heard, on a date and place set by Council.
  - d) Notification of the intent to pass a by-law to convey the public lakeshore road allowance must be sent to the Lennox & Addington County Council for its approval.
  - e) The proposed by-law is also circulated to any agencies that might be affected for comments and approval i.e.
    Bell Canada, Ontario Hydro, Ministry of Natural Resources.
  - f) Consent must be received from the Federal Government.
- 5. After the by-law to convey the public lakeshore road allowance is passed by Council, the by-law does not have any force or take effect until it has been approved by the Minister of Municipal Affairs.
- 6. Upon completion of the above procedures and the required approvals have been obtained, each property owner of an approved application must submit an acceptable survey of the extended property lines in compliance with the original application to which adjoining property owners agreed. The survey must show the lands below the high water mark lying within the public lakeshore road allowance as well as lands above the high water mark. A written legal description of the affected portions is to be submitted to Council with eight copies of the survey.
- Upon receipt of eight copies of an acceptable survey, and the written legal description, the by-law and the supporting documents are forwarded to the Minister of Municipal Affairs for approval.
- 8. When approval is received from the Minister, the applicant will be notified, and upon payment of the purchase price to the Townships of Kaladar, Anglesea & Effingham, a deed and a copy of the survey will be given to the applicant for registration by him/her or designated agent at the Deeds Registry Office, Napanee, Ontario at the applicant's expense.

REGULATIONS GOVERNING THE CONVEYANCE OF CERTAIN PUBLIC ROAD ALLOWANCES UNDER THE JURISDICTION OF THE CORPORATION OF THE TOWNSHIPS OF KALADAR, ANGLESEA AND EFFINGHAM

- 1. Applications for the purchase of the public lakeshore road allowance in the Townships of Kaladar, Anglesea and Effingham will only be considered by the Kaladar, Anglesea and Effingham Council from the registered property owner (or his authorized agent or solicitor) adjacent to said road allowance.
- Agreement in writing must be obtained from adjoining owners on all sides as to the location of the extended property line and must accompany the completed application.
- 3. Applications and agreements are to be on forms prescribed and provided by the Townships of Kaladar, Anglesea and Effingham.
- 4. A detailed sketch of the applicants land showing boundaries and dimensions, location of agreed upon extended property lines on the public lakeshore road allowance, names of adjoining owners, access to property etc. must accompany each application.
- 5. The applicant will bear all survey, legal costs and any related costs incurred by Kaladat, Anglesea and Effingham Townships - e.g. advertising, Township legal costs etc.
- 6. Each application is to be accompanied by an application fee of \$250.00, payable to the Townships of Kaladar, Anglesea and Effingham.
- 7. Applications will be accepted from a solicitor or authorized agent provided the property owner completes the authorization section of the application form.
- 8. All applications will be processed under the provisions contained in the Municipal Act, Revised Statutes of Ontario, 1980 and shall be subject to such regulations, policy and procedures as establishe by the Minister of Municipal Affairs, Province of Ontario.
- 9. The lands shall be surveyed if the Kaladar, Anglesea and Effingham Township Council approves the application.
- 10. The application shall be for a conveyance of the Public Road Allowance on or leading to water which lies above the high water mark as determined by survey. Any portion lying underwater, as determined by the high water mark shall NOT be conveyed to the registered adjoining owner. The Council may convey such area lying underwater to the Ministry of Natural Resources, Province of Ontario.
- The applicant may be requested to have surveyed, at his expense, both the lands above the high water mark and below the high water mark, lying within the Public Road Allowance contained in the application.
- 12. All surveys are to be prepared by way of Reference Plan and are to be in a manner acceptable to the Township of Kaladar, Anglesea and Effingham and Ministry of Municipal Affairs.
- If an application is terminated by an applicant any fees paid to the Township, may, at the discretion of the Council be returned to the applicant in part or in whole.
- Nothing contained in the application shall be construed to guarantee or warrant to the registered abutting property owner, the right to receive a conveyance to any portion of the Public Road Allowance.
- 15. There will be a charge for the purchase of the land when the final deed is prepared of \$250.00 plus expenses.
- There will be a restrictive covenant in the deed when issued that will state that no fence or wall or any other man made barricade or similar structure shall be erected or constructed on the lands described in the conveyance except with the permission of the Kaladar, Anglesea and Effingham Township Council and any Provincial or Federal Government Ministry which has jurisdiction or legislation applicable to the lands.
