Guest Speakers

Land O' Lakes Lions Club

Nawar Hage presented on the history of the Lions Club, (which started in 1917 in the United States), and on the more recent history of the Lions Club of Land O'Lakes which was formed in 1969. Lions Clubs have aided the blind and visually impaired, and have made a strong commitment to community service and servicing youth around the world. Currently, the local Lions Club is involved with the LandO'Lakes Food Bank, the KGH Foundation, the Mazinaw Swim club, the Pine Meadow Nursing Home, the Alzheimer Society, the Kaladar-Barrie Fire Department and the North Addington Education Centre, to name a few. Cloyne and District Historical Society

Elspeth McCulloch / Ken Hook

Elspeth McCulloch and Ken Hook presented on the history of Cloyne and area.

- There has been an Indigenous Presence first evident in the area between 800-500 B.C.
- It was noted that the oldest remaining structure in the local area is the Loon Lake School which was built in 1868.
- Logging was the main industry in the 1800's with 300-400 year old White Pine cut and squared on site. A tramway was built to move logs but a road was needed, which was built in 1856, to allow settlers into the area. In 1899 Bon Echo Inn, a 3 story inn was built in the Narrows, which later burned to the ground.
- Mining was also evident in this area including Gold, Copper and Mica.
- RCAF had a search and rescue station in the Upper Lake in the 1900's which was purchased from a lumber company.
- Skootamatta Lake is a crater which formed as part of a meteor strike about a billion years ago. There is a great debate about the meaning of Skootamatta. Based on the poet, Wallace Havelock Robb, the meaning of Skootamatta, which is an Ojibway word, appears to be, "the place where the stars spill from the river into the lake". There is a legend regarding the Lake of the Spilled Stars. The Ojibway, upon arriving at the Lake using stars as their guidance of light, noted that they no longer needed to navigate using the the stars as they had tumbled down, and filled the lake with light.

Lake Health Update

Martha Warriner joined the board as Lake Steward this past fall and looks forward to sharing information with the board.

Martha presented an in-depth review of the lake assessments that have been carried out for the past few years. Currently, Skootamatta is in good shape due to many factors.

Questions:

- Could higher levels of e-coli at Wolf Creek be due to waterfowl excrement or other issues?
 Response: Although many variables can cause an increase in e-coli, septic systems are the
 leading cause of e-coli. We encourage members to speak to their neighbours and to assess
 whether or not it is time to clean out septic systems.
- 2. Dying program, which was used at another lake, was questioned. Response: not needed on Skootamatta. The data does not support this as the data does not support this intervention.

Forestry Operations Update

Jim Chinnick provided an in-depth update on Forest Management. This update is available in the 2022 newsletter. Part of his update was reiterated as follows:

The SDRA has been an active participant in discussions related to the development of a new Forest Management Plan (FMP) for the Mazinaw-Lanark Forest, which is the forest region in which our lakes are located. This has been a rather long, and somewhat frustrating process.

The SDRA has raised several concerns regarding the proposed plan, which can be summarized as:

- Harvesting activities up to the very edge of private properties, with no buffer zone (of particular concern to property owners in Jacques Bay, north of Jacques Bay Road)
- Harvesting activities up to the edge of public and private access roads, with no buffer to protect the viewscape
- Minimal protection for damage to the extensive wetlands included in the planned harvest areas, wetlands that are directly part of the Skootamatta, Sheldrake and Pringle Lake watersheds, and key to protecting water quality and flooding control

- Lack of adequate protection for the viewscape of the shoreline as seen from the lake. These concerns were eventually brought forward to an Issues Resolution process administered by the Department of Northern Development, Mines, Natural Resources, and Forestry (NDMNRF). Unfortunately these concerns were not accepted. While the rationale for rejecting these concerns is somewhat arguable, there is no appeal process, and the plan was officially released in December, 2021.
- Work is currently underway to develop the logging road infrastructure to support the planned wood harvesting.
- 1) The gains achieved by the SDRA during the negotiations regarding the 2011 2021 FMP were retained.
- 2) The protection status of Pringle Lake was upgraded, which increases the protection around the shore line. This is a positive result for the Pringle Lake community and for Skootamatta Lake for which Pringle Lake is a key part of the watershed.
- 3) And finally, we had issues with the process that led to the development of the plan. Specifically our concerns related to the lack of involvement of the Lake Associations in the process at the beginning. Our position was that the lake front property owners are significant stakeholders in the forest region, and should have some priority in the planning process, rather than just having a reactionary role to a plan already developed.

We are making a determined effort to document what we have learned to better equip future SDRA Board members to participate in the planning process for the next Forest Management Plan.

Questions?

- Ron Nowell asked about clean up following the impact of the May 21 storm. There has been permission given to clean up the strip along Narrows Road and help to clean up the Sheldrake Bay area.
- Kent Farrow noted that the powers of the forest industry are robust and very influential. He
 noted that there were many local achievements made in the past, and that 12 years ago the
 ministry was supportive of the concerns of SDRA. He acknowledges Jim Chinnick's
 endeavours to continue to be involved and to ensure that the SDRA's interests continue to be
 heard and addressed.
